What is Early Graduation?

Ineligible Applicants

Application Period

Eligibility (Requirements must be met at the time of application)

- Early graduation allows students with excellent academic performance to graduate after completing seven semesters (students enrolled in 2016 or earlier can graduate after completing six semesters).
- A degree is awarded if the students meet all graduation requirements of their department/major and have a cumulative GPA of 4.0 or higher (including F grades).

College of Medicine, College of Nursing, School of Architecture – College of Engineering, College of Music, Transfer Students

(2026. 3. 3.(Tue.) 10:00 ~ 3. 6.(Fri.) 23:59) ※ Strict deadline! Late submissions will not be accepted.

- Students who meet the following requirements and wish to graduate in August 2026
- Students must be enrolled during the graduation semester (students on a leave of absence cannot apply).

* Remaining credits = Total credits required for graduation – Completed credits (excluding credits from courses registered in the 1st semester of 2026).

Application Method

- ① Log-In to the Student Portal (HY-in) → [Services] → [Registration status] → [Early Graduation] → Apply and Save (no additional documents required)
- ※ When applying for early graduation, check the notice on the HY-in application screen.
- ② After completing the application, an automatic confirmation email will be sent.
- ③ The Academic Affairs Team will review the application and finalize approval (an automatic email will be sent).

Application Cancelation

If you wish to cancel your early graduation application after being approved, you must inform the Academic Affairs Team before the final exams begin and follow the administrative procedures.
If you cancel after the final exams, you may be excluded from the next semester's internal scholarships.

Graduation Requirements

Approval of your early graduation application does not guarantee graduation. You must meet all the regular graduation requirements for your department.

- Maintaining a cumulative GPA of 4.0 or higher (including F grades) is required.
- The same graduation requirements apply to students with multiple majors or minors.

Early Graduation Disqualification

Some students mistakenly believe that meeting early graduation application qualifications automatically means they will graduate.

If your early graduation application is approved, but you fail to meet any of the following requirements, you will be disqualified from early graduation:

- Failure to meet any graduation requirement
- Cumulative GPA is below 4.00 (including F grades) for the graduation semester
- Students with multiple majors or minors who do not meet the graduation requirements for their major

→ **In such cases, you must complete the requirements in the following semester, and you will be excluded from the selection for campus scholarships for that term. ★Note★**

Course Enrollment

Early graduation applicants are not yet considered expectant graduates at the time of application, so they must enroll in at least 10 credits.

→ Once the early graduation approval is finalized, you will be considered an expectant graduate for that semester.

Credit Exchange

After applying for early graduation, you cannot earn credits through exchange programs such as study abroad or internships.

(However, credit exchange courses that are applied for through the Center for Smart Teaching and Learning are eligible.)

Seasonal Semesters

The graduation review may include grades from the winter seasonal semester of the 2025 academic year.

(However, social service courses offered in the seasonal semester are excluded.)

Deferral of Degree Completion

Early graduation applicants cannot apply for deferral of degree completion. If early graduation is approved, the student must graduate immediately.

FAQ

Q. I applied for early graduation but withdrew before the final exams. Will I be excluded from the next semester's scholarship selection?

A. If the cancelation of early graduation is approved before the final exams, you will not be excluded. Scholarship selection (e.g., merit-based scholarships) is handled by the Student Affairs Team (Scholarship) after grades are finalized. If you are removed from the early graduation list and reclassified as a regular student before the final exams, you will not be excluded from the scholarship selection.

Q. I applied for early graduation but failed to meet the graduation requirements and will continue into the next semester. Will I be excluded from the next semester's scholarship selection?

A. Yes, you will be excluded. Because scholarships are assigned after the final grades and graduation review occurs afterward, scholarship assignment cannot be adjusted retroactively.

Q. Does being excluded from the scholarship selection mean that I cannot apply for any scholarships?

A. This applies to internal scholarships only. External scholarships are not affected.

Q. Can an early graduation applicant obtain a certificate of expected graduation?

A. After the early graduation application is approved, you will be considered an expectant graduate, and a certificate of expected graduation can be issued after approval.
(An automatic notification email will be sent after approval.)
